Terms of Service

These Terms of Service may be amended from time to time by L.F. Investment Limited.

1. General

- 1.1. Purple-Trading.com (hereinafter called Purple Trading) is a domain owned by L.F. Investment Limited (the "Company"), a financial services company incorporated according to the laws of the Republic of Cyprus, Registration number 329493, having its registered office at 11, Louki Akrita, CY-4044 Limassol, Cyprus. The Company operates under license number 271/15 issued by Cyprus Securities and Exchange Commission (the "CySEC").
- 1.2. The Company offers an online, free of charge educational community Purple Trading Hub to You (the "**Purple Trading Hub**") subject to the following Terms of Services (the "**Terms**") which should be read carefully by You in its entirety prior to Your use of the Purple Trading Hub. Please note that these Terms constitute a legally binding agreement between You and the Company. Physical signature of the Terms is not required.
- 1.3. In addition to these Terms, please review the Company's Privacy Policy, Conflict of Interest Policy, Execution Policy, Client Complaints Policy, Client Classification Policy, Investor Compensation Fund Policy as well as other rules and policies relating to the Purple Trading Hub, available on the Company's Website, which are duly incorporated herein by reference, together with such other policies of which You may be notified of by the Company from time to time.
- 1.4. Trading foreign exchange on margin carries a high level of risk, and may not be suitable for all investors. The high degree of leverage can work against you as well as for you. Before deciding to trade foreign exchange, you should carefully consider your investment objectives, level of experience, and risk appetite. - 1.5. If you do not agree with the terms provided herein, or in the Agreement as were mentioned above, you should immediately cease using Purple Trading Hub.
- 1.6. We reserve the right to vary these Terms from time to time; this will normally be in response to a change in legislative or regulatory requirements or a change in internal policy. You will be notified of a variation to these Terms. We reserve the right to vary the Purple Trading Hub at any time.

2. Definitions

- 2.1. In this Agreement, the following words and phrases shall (unless the context otherwise requires) have the meanings set out beside them:
 - a. "Purple Trading Hub" shall mean the community of members can get together with the Educators and where they can share information with each other and with the Company. The Members will also have access to information which the Company makes available on the Purple Trading Hub.
 - b. **"Educator"** shall mean a provider of the educational content in the Purple Trading Hub other than the Members and the Admins.
 - c. **"Educational Content"** shall mean any content provided by the Company and/ or the Educator.
 - d. "Member" is a person that successfully completed the registration process of the Purple Trading Hub. The term member also includes the term "Premium Member" if not specified otherwise.
 - e. "Premium Member" is a Member that has a Live Account opened with the Company.
 - f. **"Admins' '** shall mean the Company's designated personnel who are responsible for the monitoring and general overview of the Purple Trading Hub.
 - g. "Content" shall mean any post, commentary, or video, which is published by Educators or Members and is publicly available and visible to other Educators or Members of the Purple Trading Hub.

- h. **"You" or "you"** shall mean any person, especially, but not limited to Members and Educators, who use Purple Trading Hub, either actively by publication of Content or passively by reception of the Content in any way.
- i. **"MiFID II Regulation"** shall mean Directive 2014/65/EU of the European Parliament and of the Council of 15 May 2014 on markets in financial instruments and amending Directive 2002/92/EC and Directive 2011/61/EU.
- j. **"Third Party Terms"** shall mean the terms and conditions available to Members and Educators on the website of the third party that provides the Company with the computer services that create the backend of the Purple Trading Hub.
- k. "Licensor" shall mean any party that licenses or provides any services to the Company.
- 3. Disclosure and Warnings
 - 3.1. You should not make investment decisions based on information provided by any Members or Educators in the Purple Trading Hub (who may be anonymous or unidentifiable), such as details of the trades they make or any opinions expressed by them. The Company will not be held liable in the event that you make investment decisions based on such information.
 - 3.2. If you want to use the information to help you with your own investment decisions, you do this at your own risk.
 - 3.3. <u>Content on the Purple Trading Hub which is generated by Members and/or</u> <u>Educators, does not contain advice or recommendations or endorsements by</u> <u>or on behalf of the Company.</u>
 - 3.4. Before viewing any Content posted on the Purple Trading Hub you shall acknowledge the following:
 - The Company does not endorse or guarantee the accuracy or authenticity of any postings or

information posted to the Purple Trading Hub.

b. Nobody is permitted to make postings on the Purple Trading Hub in their capacity as a

licensed advisor or as a representative of a licensed advisor.

- c. Content is only general information and is NOT professional investment advice. Therefore, you should not act based on the postings on the Purple Trading Hub. Moreover, before considering what is said in a posting, you should seek advice from an independent licensed financial advisor.
- d. Financial products cannot be offered to Members for sale or issue through the Content published on the Purple Trading Hub.
- e. Please be aware that any information posted on the Purple Trading Hub should not be considered to be investment advice or any form of financial product advice whatsoever.

4. Conditions to use the Purple Trading Hub

- 4.1. Members may use the Purple Trading Hub under the following conditions:
 - a. You must be at least 18 years of age.
 - b. You must reside in a jurisdiction where the Company is permitted to offer its services.
 - c. You successfully register as a Member of the Purple Trading Hub.
 - d. You comply with these Terms, specifically to the articles concerning the rules for the Content.
 - e. Your membership is not terminated by the Admins due to the breach of these Terms.
 - f. Additionally to the previous Conditions, the Premium Members must have opened a live account with the Company and under the same registered email as the email used for the registration form for the Purple Trading Hub registration.

5. Registration process

- 5.1. After each prospective Member fills in and submits a duly completed registration form available on the Company's website, the Company will send the prospective Member an email notice with an invitation to join Purple Trading Hub.
- 5.2. Once the Member classifies as the Premium Member according to the art. 3.1. f), they will get access to the premium private channels with additional Content from the Educators. Premium private channels offer an option to post Content by the Premium Members.

6. Content:

- 6.1. Any Member and Educator must adhere to the following content guidelines:
 - a. You shall not publish Content that is abusive, inciteful, defamatory, harassing, insulting, sexually explicit, offensive, racist, rude, hateful, threatening, violent, or illegal, is not allowed.
 - b. You shall not publish Content which may be perceived as recommendation and/or portfolio management services and/or investment advice as defined in the MiFID II Regulation, is not allowed.
 - c. You shall not publish Content which advertises or promotes another business or service or any type of commercial content is not allowed.
 - d. Your Content must not disclose any security information about and/or login credentials of yourself and/or your Purple Trading and/or Purple Trading Hub account to anyone while using the Purple Trading Hub.
 - e. Your Content must not be perceived as being endorsed or warranted or sponsored or approved by the Company.
 - f. You are solely responsible for the Content you publish on the Purple Trading Hub and for any consequences or damages that may arise from it.
 - g. You must make sure that all Content you post is your original content. The Content must belong to you or you have been granted a right to post such information. You must not violate the privacy rights, publicity rights, copyright, contract rights or any other rights of any individual or entity.
 - h. You must not make derogatory remarks regarding, defame, violate anyone's privacy or otherwise criticize any person or entity.
 - i. You may not use Purple Trading Hub to disclose information that you don't have the right to disclose, like others' confidential or personal information.
 - j. You shall never intentionally incite conflict, generate provocation or purposely upset other Members of the Purple Trading Hub. All discussions should remain polite and to the point.
- 6.2. By posting content on the Purple Trading Hub, you specifically grant us a nonexclusive, irrevocable, transferable, sub-licensable, royalty-free, worldwide license to use, copy, duplicate store, present and/or publish all or any part of your content, and the Company shall be free to use such content, in any manner or media whatsoever,

- 6.3. Any opinions, news, research, analysis, market prices, headlines, graphs, links to other websites, newsletters or information from other people, market prices for different products in real time or on a delayed basis or other information published on Purple Trading Hub are provided as general market commentary, and do not constitute investment advice. The Company will not accept liability for any loss or damage, including without limitation to, any loss of profit, which may arise directly or indirectly from use of or reliance on such information. Any information provided by the Company or by the Educators is provided for the sole purpose of assisting Members make independent investment decisions, however if You want to use the information to help you with your own investment decisions, you do this at your own risk
- 6.4.  - f. Do not use collusive and manipulation practices and avoid transferring misinformation in order to distort the financial markets, or posting the same information multiple times on various posts.

- 6.6. You shall never discuss, mention or share any content relating to the following topics:

 - e. Synthetic and manipulated media, such as, but not limited to market data, graphs, etc. (deceptively sharing synthetic or manipulated media that are likely to cause harm)
 - f. never act violently, or directly and/ or indirectly, encourage violent behavior. This includes, but is not limited to: the use of expletives, profanity, trolling, abuse, fraud or solicitation.

 - c. You must keep it secret and not disclose any login credentials to any other person or third party.
 - d. You may not impersonate others.
 - e. You must not post Content that contains malicious computer code, such as, but not limited to computer viruses or spyware. Deceiving Members to download or use or run any malicious programs or files that will compromise a Member's security is not allowed.

- i. You may not hyperlink to images or other non-hypertext content on the Purple Trading Hub other web pages.
- j. You may not remove any marks showing proprietary ownership from materials you download from the Purple Trading Hub.
- k. You may not show any part of the Purple Trading Hub on other websites with <iframe>.
- I. You may not disable, avoid, or circumvent any security or access restrictions of the Purple Trading Hub.
- m. You may not strain the infrastructure of the Purple Trading Hub with an unreasonable volume of requests or requests designed to impose an unreasonable load on information systems underlying the Purple Trading Hub.
- n. You may not encourage or help anyone in violation of these Terms.

8. Monitoring and enforcement

- 8.1. The Company reviews and monitors your activity in the Purple Trading Hub and has the right to restrict your usage on, or terminate your Purple Trading Hub account, in the event you are found to be in breach of these Terms, during the monitoring.
- 8.2. You agree that the Company may keep a record of any means of communication and activity between you, the Company and/or any Member and Educator, in the Purple Trading Hub, and that such records will be the Company's sole property.
- 8.3. The Company may investigate violations of these Terms to the fullest legal extent. The Company may notify and cooperate with law enforcement authorities in prosecuting violations of the law and these Terms.

9. Liability

Without prejudice to any other rights of the service providers of the Company, failure to comply with these terms or violation of these terms may result in suspension or deactivation of your use of the Purple Trading Hub with or without notice.

14. Amendment of the Purple Trading Hub Terms

- 14.1. Unless provided differently elsewhere in these Terms, the Company has the right to amend these Terms at any time giving you at least 5 Business Days Written Notice prior to such changes. Any such amendments will become effective on the date specified in the notice.
- 14.2. You acknowledge that a variation which is made to reflect a change of law or regulation may, if necessary, take effect immediately. These Terms and any other rules and policies referred to herein or incorporated by reference hereto, as may be updated or amended from time to time by the Company, constitute the entire and whole agreement between You and the Company.
- 14.3. You confirm that, in agreeing to accept these Terms, You have not relied on any representation except for any express representation made by the Company in these Terms.

15. Severability

15.1. Should any part of these Terms be held by any court of competent jurisdiction to be unenforceable or illegal or contravene any rule, regulation or by law of any market or regulator, that part will be deemed to be amended to the minimum extent necessary so that it is compliant with such rule regulation or law or, and where the aforementioned is not possible, that part will be deemed to have been excluded from

17.1. The Company may at any time transfer, assign or novate any of its rights, benefits or obligations under these Terms subject to providing previous notification to you. You may not transfer, assign, charge, novate or otherwise transfer or purport to do so your rights or obligations under these Terms without prior written consent of the Company.
