## Consent to the processing of personal data

(hereinafter the "Consent")

  - o Tied agent and/or other providers
  - Outsourcing companies providing regulated and/or unregulated services to Company. (hereinafter the "Processors" or "Recipient")

In order to fulfil the Purpose, the Controller does not intend to transfer the Personal data outside of the EHP.

The Controller guarantee, that all the Processor/Recipient's personal data policy are compliant to GDPR and specifically to Consent.

- 8. You hereby acknowledge that as the data subject, you have following rights as follows from the provisions of the GDPR towards Controller and all the Processors/Recipients.
  - o the right to withdraw the consent granted at any time either in full or in relation to a specific purpose of processing (shall be done via clicking the "unsubscribe" link in the footer of the email received or via contacting the Controller/Processor/Recipient via one of the abovementioned means);
