

## **COOKIES POLICY**

Our Websites use cookies to improve your browsing experience.

The data controller is **L.F. Investment Limited** (the **"Company"**). Detailed information about the processing of personal data, including your rights, can be found in our Privacy Policy, <u>here</u>.

Websites use cookies to distinguish you from other users of our website. This helps Company to provide you with a good experience when you browse our website and also allows us to improve Websites.

A cookie is a small text file that we store on your browser or the hard drive of your computer if you agree. Cookies contain information that is transferred to your computer's hard drive. The information is used for the purpose of optimizing the services provided through Company websites, including related websites specified below, subpages and links (herein as **"Websites"**).

Some cookies are absolutely necessary to enable you to move around our Website and use its features. Without these cookies, essential security features cannot be activated and services you have asked for cannot be provided. Each Website may send its own cookies to your browser if your browser settings allow it.

Our Websites have enabled Google Consent Mode to ensure that user consent to the use of cookies and to the processing of user's personal data may be passed to Google in specific cases (particularly for marketing purposes). This ensures that Google products (e.g., Google Analytics, Google Ads) correctly adjust their behaviour according to the user's cookie preferences, depending on whether the relevant cookies have been allowed or denied.
