

TERMS AND CONDITIONS OF THE LOTTERY "GUESS AND WIN"

- 1. The Organizer of this competition "Guess and Win" (hereinafter referred to as "Competition") is L.F. Investment Limited, 11, Louki Akrita, CY-4044 Limassol, Cyprus, a licensed Cypriot Investment Company regulated by CySEC License No. 271/1 (hereinafter referred to as "Organizer").
- 2. The Competition takes place from 3rd May 2022, 0:00 CET (12 AM) until 27th May 2022, 18:00 CET (6 PM) on the website of the organizer (https://www.purple-trading.com/cs/www.purple-trading.com/cs/moneyexpo-2022/) (hereinafter "Website"). The participants may take a guess in person and enter the Competition at the FPG MoneyExpo 2022 conference that takes place from 21st to 22nd May 2022 organized by Financial Progress Group a.s. Perlitová 1820, 140 00 Praha 4 (hereinafter referred to as "Conference").
- 3. The 1st prize is a gift voucher for 2-nights wellness VIP stay package at Infinit Maximus Brno, Hrázní 4a, Brno Kníničky. The price includes accommodation for 2 persons for 2 nights, wellness entry and half board, as specified in the gift voucher (hereinafter referred to as "Prize"). The voucher shall be used on the date chosen by the winner during the validity period of the gift voucher. Organizer shall not compensate the Winner in case they do not use the voucher on time. The Prize does not include transportation and/or any other additional purchases, fees and charges besides the ones specified above and in the voucher. The winner has full responsibility to comply with the relevant health regulation, especially Covid-19 travel restrictions and regulations, applicable during the whole duration, including departure and arrival to the accommodation.
- 4. Prizes will be awarded to winners in order depending on the accuracy of their guess. The Prizes shall be awarded to and used exclusively by the winners; no substitution is allowed.
- 5. The winner is responsible for settling all public and legal obligations resulting from winning a prize in the Competition.
- 6. To enter the Competition, you must guess the value of DAX (Index DE40) at exactly 22:00:00 CET (10 PM) on 27th May 2022. To complete your entry, you need to guess the DAX value, by indicating in its content such elements as: how much will be (with value up to first decimal place) price (BID price) DAX (Index DE40) on 27th May 2022 at 22:00:00 CET (10 PM) as quoted at DAX_ECN symbol in MT4 platform on Purple Trading ECN account with Prime trading conditions; and provide your correct personal data: name, phone number and email address, and disclose your guess to either on Organizer's Website or to the Purple Trading hostess during the FPG Money Expo 2022 Congress who will write it down on the Website, or at the Purple Trading stand, together with your name and contact details. The entry shall be completed during the FPG Money Expo 2022 Congress on 21st and 22nd May 2022, or on Website, and no later than 18.00 CET (6 PM) on 27th May 2022. All mandatory fields must be filled in for the entry to be valid. There can be only one entry per person.
- 7. The employees of the Organizer or any persons hired to provide a service to the Organizer, including, but not limited to personnel of the Financial Progress Group, a.s. employees, hostesses, speakers, as well as the speakers who are providing a presentation during the Conference cannot enter the Competition.
- 8. Entry into this competition indicates an acceptance and agreement of all these Terms & Conditions. If you do not agree to these terms and conditions, you should not enter the





competition.

- 9. The Organizer takes no responsibility for the Prize once it has been awarded to the winner except as required by law. The Prize is awarded once sent to the winner's email that was provided with the entry to the Competition.
- 10. The winner is the person who will guess the closest number to the numerically expressed value of DAX (Index DE40) at exactly 22:00:00 CET (10 PM) on 27th May 2022 as quoted at as quoted at DAX_ECN symbol in MT4 platform on Purple Trading ECN account with Prime trading conditions. There will be 1 (one) prize winner who receive a Prize as defined in Art 3 of this Terms and Conditions. If multiple correct guesses are made, the prize will be awarded to the participant with the earliest guess. The time of the guess shall be determined solely by the Organizer, on the basis of the time when the Website received the guess by the participants.
- 11. The Prize is not exchangeable and not redeemable for cash. Any attempts made by the winner to sell the prize may result in cancellation by the Organizer.
- 12. The winner will be informed that he won via email and/or phone on 30th May 2022.
- 13. The Organizer reserves the right to verify the validity of entries and reserves the right to disqualify any entrant for tampering with the entry process, including but not limited to making multiple entries or for submitting an entry that is not in accordance with these terms and conditions.
- 14. All decisions made by the Organizer are final and no correspondence will be entered into.
- 15. The Organizer reserve the right to vary any of the terms of entry applying to this Competition or to modify, terminate, suspend or reschedule the Competition at any time.
- 16. The Organizer shall not be liable for any loss, damage or personal injury (including but not limited to indirect or consequential loss) suffered by any person arising directly or indirectly out of or in connection with entering this competition or claiming/winning any prize, except as required by law. This applies to whole duration, including departure and arrival, of the wellness stay.
- 17. All entries remain the property of the Organizer. All personal information will be collected and stored by the Organizer in accordance with the Privacy Policy of the Organizer, available at this <u>link</u> and local privacy regulation.
- 18. The winner grants his consent to use the winners' name and photo for the marketing purposes of the Organizer.
- 19. The Organizer reserves the right to amend the Regulations without prior notification to the Competition Participants.
